Category of Membership

- (a) Direct Participant (DP) Each DP maintains a Euro settlement account with Standard Chartered Bank (Hong Kong) Limited in the capacity of the Euro Clearing Settlement Institution ("Euro SI") to clear and settle Euro CHATS payments.
- (b) Indirect CHATS User (ICU) ICU does not maintain any settlement account with the Euro SI. Its Euro CHATS payments are processed by a DP.
- (c) Third Party User (TPU) TPU does not maintain any settlement account with the Euro SI. Its Euro CHATS payments are processed by its DP(s). A TPU can enter into sub-settlement agreements with more than a DP and has to provide its own SWIFT BIC for identification. If a TPU has no SWIFT BIC, it has to provide the account number of its account maintained with its DP for identification, which is displayed only when consent are given by both the TPU and its DP.
