



## **List of USD Clearing Participants as of 28 July 2025**

### **Category of Membership**

- (a) Direct Participant (DP) – Each DP maintains a USD settlement account with HSBC in the capacity of the USD Clearing Settlement Institution (“USD SI”) to clear and settle USD CHATS payments and bulk clearing items.
- (b) Indirect Participant (IP) – IP does not maintain any settlement account with the USD SI. Its USD CHATS payments and bulk clearing items are settled through a DP.
- (c) Indirect CHATS User (ICU) – ICU does not maintain any settlement account with the USD SI. Its USD CHATS payments are processed by a DP.
- (d) Third Party User (“TPU”) – TPU does not maintain any settlement account with the USD SI. Its USD CHATS payments are processed by its DP(s). A TPU can enter into sub-settlement agreements with more than a DP and has to provide its own SWIFT BIC for identification. If a TPU has no SWIFT BIC, it has to provide the account number of its account maintained with its DP for identification, which is displayed only when consent are given by both the TPU and its DP.
